The name of the Corporation is WHITE STALLION MANAGEMENT, INC. (the "Corporation").

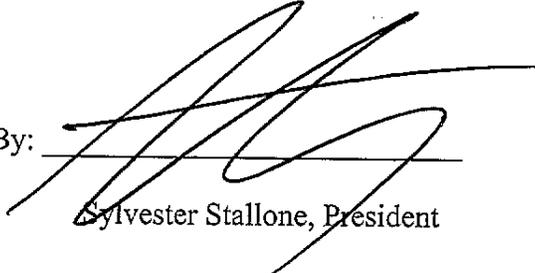
ARTICLE II - DATE DISSOLUTION WAS AUTHORIZED
