ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PHILLIPS, EISINGER, KOSS & ROSENFELDT, P.A.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, PHILLIPS, EISINGER, KOSS & ROSENFELDT, P.A. (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation, as previously amended:
