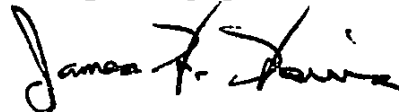

The corporation is dissolved as of March 1, 1997.

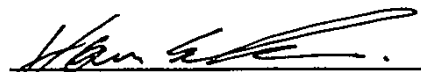

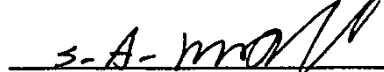
The number of shares cast by the shareholders for dissolution was sufficient for approval.
