ARTICLES OF INCORPORATION

- n) To transact any lawful business which the Board of Directors shall find will be in aid of governmental policy.
- o) To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans, and other incentive plans for any or all of its directors, officers, and employees and for any or all of the directors, officers, and employees of its subsidiaries.
- p) To be a promoter, incorporator, parener, member, associate, or manager of any corporation, partnership, joint venture, trust, or other enterprise.
 - q) To have and exercise all powers necessary or convenient to effect its purposes.

Article IV - Capital Stock

The aggregate number of shares which the Corporation shall have authority to issue is the total sum of 1,000 shares, having \$1.00 par value. The consideration to be paid for each share shall be fixed by the Board of Directors.
