#### CAPITAL STOCK

- (a) This corporation is authorized to issue five thousand shares (5,000) at \$.01 per share of per stock. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property or in labor or services at a fair valuation to be fixed by the Board of Directors at a meeting called for such purposes.
