We, the undersigned, being of full age, sui juris and Asia Machine of ORIDA the United States, hereby file these Article: for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liability, privileges and immunities of a corporation for profit.


