## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is VERO MANAGEMENT CORP.

Article 2. Principal Office. The principal place of burlness and mailing address shall be 2019 - 14th Avenue, Vero Beach, FL 32960.

Article 3. Duration. The Corporation's existence shall commence January 1, 1996 and its duration shall be perpetual thereafter.
