Dear Sir or Madam:

In mid-year 2003, Orlando Software Group, Inc. moved our offices to 1025 Greenwood Blvd., Lake Mary, FL 32746. The office building and offices services including phone and mail where provided by PS Executive Centers, Inc. an Ohio based compay.

In January of this year, PS Executive Centers filed for protection under Chapter 11. There were over 25 tenant corporations affected. Phone calls and all mail were forwarded to Ohio under direction of the bankruptcy court. Existing mail (inbound and what was outbound at the time) was to be forwarded to new addresses provided by each tenat.

OSG never received any of the mail that was sent to our business address after January. Nor was any of the mail in-process from December ever delivered. It took many weeks for us to relocate our offices and to get our new business address communicated to all concerned.

Consequently, we failed to receive the forms and notice for our annual report filing. Additionally, the person who normally handled these duties is no longer with the company. Mail sent to his attention and the old OSG business address was being forwarded to the closed office address which ended up in Ohio, further compounding the problem.
