The undersigned, acting as Incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

- FIRST: The name of the corporation is: **Spec One Associates, Inc.**
- SECOND: The period of duration of the corporation: **Perpetual.**
- THIRD: The purpose or purposes for which the corporation is organized are: To engage in any activity or business permitted under the laws of the United States and of this State.
- FOURTH: **AUTHORIZED SHARES:**
- NUMBER OF SHARES - The aggregate number of shares, which the corporation shall have the authority to issue is: One Thousand (1000) shares of capital stock with NO Par value per share.
