

ARTICLES OF INCORPORATION OF STONE CIRCLE STUDIOS, INC.



The undersigned Incorporator subscribing to these Articles of Incorporation, being competed to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I
