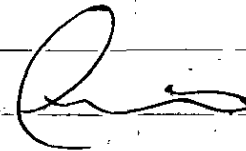

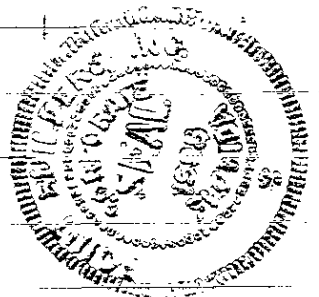
THIS LETTER IS TO CERTIFY THAT I, THE PRESIDENT
