ARTICLE I - NAME

The name of this Corporation is ROBERT J. MASON, INC., and the address is 3007 Lake Woodward Drive, Eustis, Florida 32726.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall begin at 12:01 A.M. on January 1, 1996, and shall thereafter exist perpetually.

ARTICLE III - NATURE OF BUSINESS

This Corporation may engage or transact in any or all activities or businesses permitted in the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK

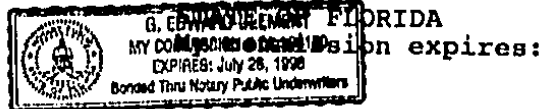
