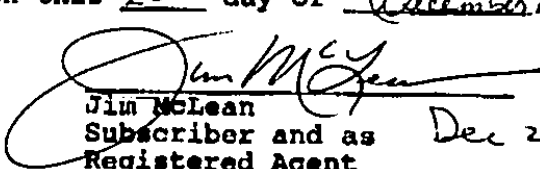
ARTICLE IX INDEMNIFICATION
