

ARTICLE I

Name

The name of the corporation is CRIME VICTIMS COMPENSATION CENTER, P.A., A LAW FIRM and its address is 1415 Weeping Willow Way, Hollywood, Florida 33019.

ARTICLE II

Duration

The duration of the corporation shall be perpetual.

ARTICLE III

Purposes

This corporation is organized for the purpose of practicing law in the State of Florida or any other State allowed by law and to carry on all business permitted under the laws of the United States of America and the State of Florida which is not in conflict with the aforesaid purpose.


ARTICLE VIII

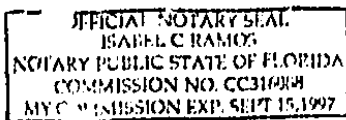
