**ARTICLES OF INCORPORATION
OF
RI/DISPO INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is RI/DISPO Inc.

ARTICLE II

MAILING ADDRESS

The mailing address of the corporation is One S.E. Third Avenue, 27th Floor, Miami, Florida 33131.

ARTICLE III

CAPITAL STOCK
