# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

### DEEDCO CENTER COURT, INC.

The undersigned, as Executive Director of DEEDCO CENTER COURT, INC., a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act, states as follows:

- 4. The amendment to the Articles of Incorporation of the Corporation was approved by a joint unanimous consent of the board of directors and shareholders of the Corporation on November 2, 2005.
- 5. The Amendment was approved by unanimous consent of all of the shareholders entitled to vote thereon.
