ARTICLES OF INCORPORATION

OF

OPERATIONAL GUIDANCE, INC.

The undersigned subscribers being natural persons competent of contract hereby distributed following Articles of Incorporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE

Name: The name of the corporation is OPERATIONAL GUIDANCE, INC.

ARTICLE II

<u>Duration</u>: This corporation shall exist perpetually.

ARTICLE III

<u>Purpose</u>: The purpose of this corporation is to have and exercise any and all powers necessary or convenient to effect its purpose and to otherwise engage in any lawful business permitted under the laws of the State of Florida.

ARTICLE IV

<u>Capital Stock:</u> This corporation is authorized to issue 10,000 shares of capital stock.

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE V

Initial Registered Office and Agent: The street address of the initial registered office of the corporation is 1400 Centrepark Blvd., Suite 909, West Palm Beach, Florida and the registered agent is Donald J. Freeman.
