ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. Name. The name of the Corporation is: THE ATTIC ANTIQUE EMPORIUM, INC.

ARTICLE 2. Effective Date. The effective date for the existence of this corporation is January 1, 1996.

ARTICLE 3. <u>Duration</u>. The duration of the Corporation is perpetual.

- ARTICLE 4. <u>Purpose</u>. The general purposes for which the Corporation is organized are the following:
 - A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
