The undersigned hereby makes, subscribes, acknowledges And FSTATE files these Articles of Incorporation for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be OLDIES - BUT - GOODIES, INC.

ARTICLE II

CORPORATE DOMICILE

NATURE OF BUSINESS
