ARTICLES OF INCORPORATION
OF
AGRILOG INTERNATIONAL TERMINAL, INC.

First: The corporate name that satisfies the requirements of Section 607.0401 is: Agrilog International Terminal, Inc.

Second: The street address and mailing address of the initial principal office is 450 Grain Exchange Building, 400 South Fourth Street, Minneapolis, Minnesota 55415.

Third: The number of shares the corporation is authorized to issue is:

(a) 100 shares of common capital stock, without par value, which shall have voting rights, all of which shall be of the same class.

(b) 100 shares of non-voting preferred capital stock, and each share shall be of a par value of \$100. The dividend, if any, to be paid upon such preferred shares shall be determined by the Board of Directors of the corporation. Preferred shares shall have preference over common shares with respect to any distribution, including dividends and distributions upon the dissolution of the corporation. The Board of Directors of the corporation is granted the express authority to fix by resolution, any designations, powers, preferences, rights, qualifications, limitations or restrictions with respect to the preferred stock prior to issuance thereof.

Fourth: Provisions granting preemptive rights are: None.

Fifth: Provisions for regulation of the internal affairs of the corporation shall be set forth in the Bylaws of the corporation.

Sixth: The street address of the initial registered office of the corporation is c/o C T Corporation System, 1200 South Pine Island Road, City of Plantation, Florida 33324, and the name of its initial registered agent at such address is C T Corporation System.

Seventh: The number of directors constituting the Board of Directors of the corporation is one (1), and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until his successors are elected and shall qualify is: Jeff Peters, 450 Grain Exchange Building, Minneapolis, Minnesota 55415.

Eighth: The name and address of the incorporator is: Jeff Peters, 450 Grain Exchange Building, Minneapolis, Minnesota 55415.
