## ARTICLE I - NAME

The name of this Corporation is The Osprey Group, Inc.

## ARTICLE II - DURATION

This Corporation shall exist perpetually commencing on the date of the effectiveness of these Articles. The corporation's existence shall commence effective <u>January 1</u>, 1996.
