The undersigned Incorporator of these Articles of Incorporation, a natural person competent to contract, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is TLS REPORTING, INC.

ARTICLE II

PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III

CAPITAL STOCK

The amount of the capital stock which the corporation shall have authority to issue is 100 shares of common stock with a par value of \$ 1.00 per share.

Shares held by the initial shareholder may not be resold or otherwise transferred to other persons unless first offered to the corporation and then to the remaining shareholders of this corporation. The price and terms at which, and the time within which such shares may be offered and sold shall be further specified by a by-law of this corporation.

ARTICLE V

DURATION

The corporation is to exist perpetually commencing at the time of filing of the Articles of Incorporation by the Secretary of State.

ARTICLE VI

INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT

The initial registered office of this corporation and its principal place of business shall be 9157 Sun Terrace Circle, Lake Park, Florida 33403, with the privilege of having branch offices at other places within or without the State of Florida. The initial registered agent of said corporation at the above address shall be Tracey L. Spataro.

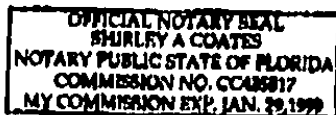

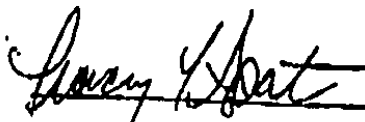
