CERTIFICATE OF ARTICLES OF INCORPORATION

95 DEC 26 11 9 41 The undersigned for the purpose of forming a corporation under the laws of the State of Florida, by and under the provisions for the formation, liability, rights, privileges of Olimba and immunities of a corporation for profit, adopt the following Articles of Incorporation.

ARTICLE 1

This corporation may engage in any activity of business permitted under the laws of The United States and of this State.
