ARTICLES OF INCORPORATION OF E-PRESS CORP.

The undersigned, acting as incorporator of E-PRESS CORP., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I

· NAME

The name of the Corporation is: E-PRESS CORP.

ARTICLE II

COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence on January 2, 1996.

ARTICLE III

DURATION

The duration of the Corporation will be perpetual.

ARTICLE IV

PURPOSE

The general purpose or purposes for which the Corporation is organized is to transact any and all lawful business for which a corporation may be incorporated under the Florida Business Corporation Act.

ARTICLE V

PRINCIPAL OFFICE

INDEMNIFICATION

The Corporation shall reimburse each person for all costs and expenses, including attorneys' fees, reasonably incurred by him in connection with any such liability in the manner provided for by law or in accordance with the Corporation's Bylaws.

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he may be lawfully entitled, nor shall anything therein contain or restrict the right of the Corporation to indemnify or reimburse such person in any proper case even though not specifically provided for herein.
