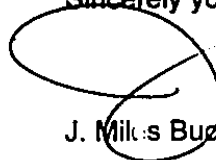
Dear Ms. Hall:

In reviewing our records, we note there is a(n) BRUCE A. KAHAN, M.D., P.A., Document number S27645, in existence.

Because of the similarities between the existing corporation and the one you are now seeking to file with us, and because it is our duty to assure that all fees due this office in accordance with section 607.0130(2)(c), Florida Statutes, are collected, we are returning the articles of incorporation unfiled and must request you return the existing corporation to good standing by completing the enclosed reinstatement application and submitting it with the appropriate fees.

ARTICLES OF INCORPORATION

OF

BRUCE KAHAN, M.D., P.A.

The undersigned natural person, competent and licensed to practice medicine in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of this Corporation is: Bruce Kahan, M.D., P.A.

ARTICLE II. PRINCIPAL OFFICE

The principal office of the corporation is 17534 Edinburgh Drive, Tampa, Florida 33647.

ARTICLE III. PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of medicine, and all its fields of specializations;
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be practitioners of medicine in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation;
- c. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law;
- d. To engage in no other business other than the rendition of the professional services specified herein; and
- e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK AUTHORIZED

a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be 7,500 shares of common stock at one dollar (\$1.00) per share par value;

b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services; and

c. Shares of the corporation's stock and certificates shall be issued only to practitioners of medicine in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this Corporation.

ARTICLE V. DURATION

The Corporation shall have perpetual existence, and shall commence on the date of filing of these Articles.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 17534 Edinburgh Drive, Tampa, Florida 33647, and Bruce Kahan, M.D. is the name of the initial registered agent of this Corporation at that address.

ARTICLE VII. INCORPORATOR

The name and address of the person signing these Articles is:

Bruce Kahan, M.D., 17534 Edinburgh Drive, Tampa, Florida 33647.

ARTICLE VIII. INITIAL BOARD OF DIRECTORS

The number of members of the initial board of directors shall be one (1). The number of directors may be increased or decreased from time to time by a resolution of the majority of the stockholders but shall never be less than one. The name of each initial director of this Corporation is Bruce Kahan, M.D., whose address is 17534 Edinburgh Drive, Tampa, Florida 33647.

ARTICLE IX. INFORMAL SHAREHOLDER ACTION

Any action of the shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all the shareholders entitled to vote upon such action at a meeting and filed with the secretary of the corporation as part of the corporate records.

ARTICLE X. SEVERANCE AND TERMINATION OF EMPLOYMENT

If any officer, director, stockholder, agent or employee of this Corporation becomes legally disqualified to render the professional services for which the corporation is organized, or accepts employment that places restrictions or limitations on his continued rendering of such professional services, he or she shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the corporation on account of any professional services. The corporation shall forthwith upon such disqualification of any shareholder, purchase such shareholder's shares and pay him all amounts owing and lawfully due to him by the corporation, except that such shares shall not be entitled to dividends.

ARTICLE XI. INFORMAL DIRECTOR ACTION

If all of the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the board of directors.

ARTICLE XII. INDEMNIFICATION

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XIII. BYLAW AMENDMENT

The power to adopt, alter, amend or repeal the bylaws of this corporation shall be vested in the board of directors and stockholders provided that such amendment be in compliance with the laws of Florida governing a Professional Service Corporation.

ARTICLE XIV. ACCEPTANCE BY REGISTERED AGENT

The undersigned Registered Agent, by executing these Articles, states that such Registered Agent is familiar with and accepts the duties and responsibilities of Registered Agent for Bruce Kahan, M.D., P.A.
