The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I - CORPORATE NAME: The name of the Corporation is: FIGURAMA, INC.

ARTICLE II - NATURE OF CORPORATE BUSINESS:

To operate any or all activities or business permitted under the Laws of the State of Florida and the United States of America.

ARTICLE III- CAPITAL STOCK:

Shares of Capital Stock of this Corporation shall be issued initially to the following person(s) in the amount(s) set opposite their name(s):

Shares held by the initial shareholders listed above may not be resold to other persons unless such shares are first offered to the remaining shareholder(s) or to the Corporation. The Corporation shall indemnify any Officer or Director, or any former Officer and Director, to the full extent permitted by Law.


ARTICLE XIX -CONFLICT OF INTEREST:
