ARTICLE V. TERM OF EXISTENCE

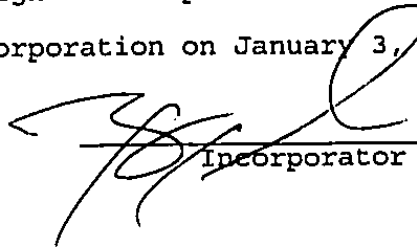
