The undersigned, acting as Incorporator and as Subscriber of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE 1

NAME

The name of this corporation is TEGIMPEX, INC.

ARTICLE 2

DURATION

The period of its duration is perpetual. The date and time of commencement of the corporate existence is the time of filing these Articles of Incorporation with the Department of State of the State of Florida.

ARTICLE 3

GENERAL PURPOSES

The purpose is to engage in any activities or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE 4

CAPITAL STOCK

The corporation shall have the authority to issue 7,500 shares of common voting stock having a par value of \$1.00 per share.

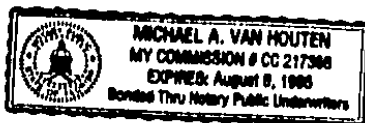

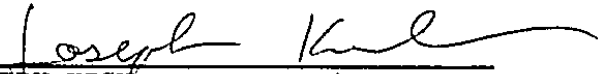
