

In response to your letter dated April 9, 2002 we are writing to explain to you that the officer of this corporation never received any notification that the registered agent had resigned – not from him nor the Dept of State.

The previous registered agent was the attorney that initially prepared the articles for the owner and apparently wanted to remain as registered agent. Had any of us known of his resignation, I would have immediately advised the owner to file articles of amendment to replace the registered agent.

More so, I had recommended to the owner to go ahead and put himself as the registered agent starting this year to avoid paying the attorney fee for being registered agent. As such we filed the annual report on time and with the appropriate fee.

Also, let it be known that this is a small business which sells used tires and provides car repairs to the public. They have never filed their report late in the past. Business is very slow and this penalty to reinstate would create a heavy burden on the owner and his one employee. As such, the owner and I humbly ask the department to consider the waiving of the reinstatement fee and accept of his check his \$150.00.
