

ARTICLES OF INCORPORATION

THE PALMS OF OKALOOSA ISLAND DEVELOPMENT CORPORATION, INC.

Article I - Name

The name of this corporation is The Palms of Okaloosa Island Development Corporation, Inc., a Florida Corporation. The initial address of the principal office and mailing address is 245 Hunters View, Roswell, Georgia, 30075.

Article II - Duration

This corporation shall exist perpetually, commencing with the date of execution and acknowledgment of these Articles.
