## ARTICLES OF INCORPORATION OF DENTAL SERVICES OF MURDOCK, INC.

The undersigned Incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I. CORPORATE NAME

The name of this corporation shall be Dental Services of Murdock, Inc.

# ARTICLE II. PURPOSE AND NATURE OF CORPORATION

The purpose of the Corporation and the nature of its business are as follows:

- 1. To provide dental treatment services;
- 2 To generally engage in and carry on any business incidental to the provision of dental treatment services;
- 3. To purchase and own real and personal property necessary or desirable for the provision of dental treatment services;
- 4. To do everything necessary, proper, or convenient for the accomplishment of any of the purposes set forth herein; and,
