ARTICLES OF INCORPORATION

OF

ARBUCKLE & ASSOCIATES, INC.

The undersigned Incorporator of these Articles of Incorporation is a natural person competent to contract and hereby forms a corporation for profit under the General Corporation Act and other laws of the State of Florida.

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is Arbuckle & Associates, inc. and its principal office is located at 6030 Bowdendale Avenue, odeksonville Florida 32216 with a mailing address at P.O. Box 37115, Jacksonville, Fl 32216.

ARTICLE II. DURATION

This corporation is to exist perpetually beginning on Januar 1996.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CORPORATE POWERS

This corporation shall have all and singular the following powers:

To purchase and acquire any or all of its shares owned and held by any such stockholder as should desire to sell, transfer or otherwise dispose of his shares, or any or all of its shares owned and held by a stockholder who dies, provided, however, the capital of this

corporation cannot be impaired thereby.
