ARTICLES OF INCORPORATION OF
G & G ENTERPRISES OF LAKE COUNTY, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article I

The name of this corporation is G & G Enterprises of Lake County, Inc. The principal office and mailing address of the corporation are: 15436 County Road 455, Montverde, Florida, 34756.

Article II

The duration of the corporation is perpetual.

Article III

The general purpose of the corporation is to engage in and to transact all business which is lawful under the laws of the United State of America and the State of Florida.
