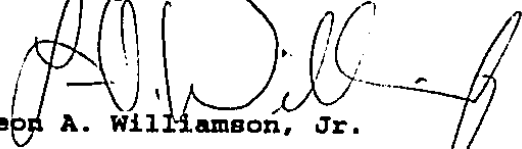

OF

The undersigned subscriber to these articles of incorporation, being duly licensed to practice dentistry under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

**ARTICLE I - NAME**

The name of the professional service corporation is Frank J. Sierra, DMD, P.A.

**ARTICLE II - PRINCIPAL OFFICE**

The principal office and mailing address of this corporation are 5420 Webb Road, Suite C-2, Tampa, Florida 33615.

**ARTICLE III - PURPOSE**
