ARTICLES OF INCORPORATION OF FRANK J. SIERRA, DND, P.A.

The undersigned subscriber to these articles of incorporation, being duly licensed to practice dentistry under the live of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621 and other laws of the State of Florida.

ARTICLE I - NAME

The name of the professional service corporation is Frank J. Sierra, DMD, P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of this corporation are 5420 Webb Road, Suite C-2, Tampa, Florida 33615.

ARTICLE III - PURPOSE
