### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

### ARTICLE ONE

The name of the corporation is DECOR ART GALLERY INC.

## ARTICLE TWO

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is January 1, 1996.

## ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To engage in the business of art gallery sales.
- 2. To transact any other lawful business for which a corporation may be formed and allowed to do under the Florida General Corporation Act.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the aloregoing.

### ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class, and shall have a par value of \$ .10 per share.

### ARTICLE FIVE

The street address of the initial registered office and the principal office of the corporation is 11527 Turnstone Drive, W. - 2. Any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock of the corporation of any class or classes, or to which is attached or pertinent any warrant or warranteer other Instrument or Instruments conferring on the holder the right to subscribe for or purchase from the corporation any shares of its stock of any class or classes.

### ARTICLE NINE

The affirmative vote of all shares of the corporation represented at a meeting which a quorum is present shall be required to amend these Articles so as to increase or decrease the authorized number of, or change the designations, preferences, qualifications, limitations, restrictions, or special or relative rights of any of the various classes of shares; or to merge or consolidate the corporation with or into any other corporation, or sell, lease, or convey all or substantially all of the assets of the corporation, or voluntarily to dissolve, liquidate or wind up its affairs.
