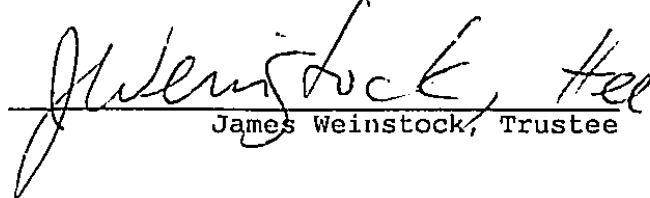
Article XI - Amendments to Articles
