ARTICLES OF INCORPORATION
OF
ILLUMINATING IDEAS, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I
NAME AND ADDRESS

1. The name of this corporation is Illuminating Ideas, Inc. and the address of the corporation is 528 Date Palm Drive, Lake Park, FL 33403-3323.

ARTICLE II
DURATION

2. The duration of this corporation shall be perpetual.

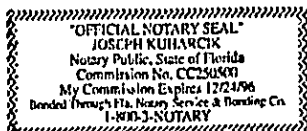


