The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a Corporation under the Close Corporation Laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be: M. H. PRITCHETT SPECIAL ACCOUNT, INC.

ARTICLE II. NATURE OF BUSINESS
