THE UNDERSIGNED incorporator hereby makes, subscribes, acknowledges and files with the Department of State the Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of State of Florida.

ARTICLE 1 The name of the Corporation is:

CHRISTOPHER NA'RYAN & CO., INC.

ARTICLE 11 Nature of Business:

The general nature of the business to be transacted by this corporation will be to engage in any activities or business permitted under the laws of the United States and of this state.

ARTICLE 111 Capital Stock

The maximum number of shares of capital stock authorized to be issued by this corporation shall be five hundred shares of common stock with a par value of \$1.00 per share.
