CERTIFICATE OF INCORPORATION

ARTICLE ONE

NAME

The name of this Corporation shall be:

MICHAEL JAMES CONSTRUCTION, INC.

ARTICLE TWO NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

TERM OF EXISTENCE

This Corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: December 28, 1995.

ARTICLE FOUR

MINIMUM CAPITAL

The amount of capital with which the Corporation shall begin business shall not be less than Five Hundred Dollars (\$500.00), or such greater amount as may be required by law

ARTICLE FIVE

NUMBER OF DIRECTORS

This Corporation shall at all times have at least one Director who is a citizen of the United States of America. The Stockholders of this Corporation may, from time to time, and at any time, increase or diminish the size of the Board of Directors of this Corporation, provided that the Corporation shall at all times have a minimum of one Director.

ARTICLE SIX

CLASSES OF DIRECTORS

The By-Laws of this Corporation may provide that the Directors be divided into two or more classes whose terms of office shall respectively expire at different times, provided that no such term shall continue longer than three (3) years, and provided further that at least one-fourth (1/4) in number of the Directors shall be elected annually.

ARTICLE SEVEN

AMENDMENT

This Certificate of Incorporation may be amended in any manner consistent with the laws of the State of Florida.

ARTICLE EIGHT

CAPITAL_STOCK

This Corporation is authorized to issue shares of stock as follows:

- A. <u>Designation</u>: The stock of the Corporation shall be known as Common Stock.
- B. <u>Authorized:</u> The maximum number of shares of Commom Stock that this Corporation may issue is: 500 Shares
- C. Par Value: Each share of Common Stock shall have the par value of: \$1.00 per Share
- D. <u>Consideration</u>: Shares of Common Stock may be issued in exchange for cash, real property, labor or services rendered, or any combination of the aforegoing. In absence of fraud in the transaction, the judgement of the Board of Directors as to the value of any such consideration shall be conclusive.
- E. Non-Assessibility: Each share of Common Stock shall be issued in exchange for consideration which is at least equal to the par value thereof, and shall be fully paid and non-assessible.
- F. <u>Voting Rights:</u> Each share of Common Stock shall entitle the record holder thereof to one vote upon each proposal presented at meetings of the stockholders of the Corporation.
- G. <u>Cumulative Voting</u>: No holder of Common Stock shall be entitled to any right of cumulative voting.
- H. <u>Dividends</u>: Record holders of Common Stock are entitled to recieve their pro-rata share of any dividends that may be declared by the Board of Directors out of assets legally available for such purposes.
- I. <u>Liquidation Rights:</u> Holders of Common Stock are entitled, in the event of liquidation or dissolution of the Corporation, to recieve their pro-rata share of any assets of this Corporation remaining after payment of all corporate debts and other obliquations.
