AMERICAN COMPUTER TECHNOLOGIES OF LAKE LAND, INC.

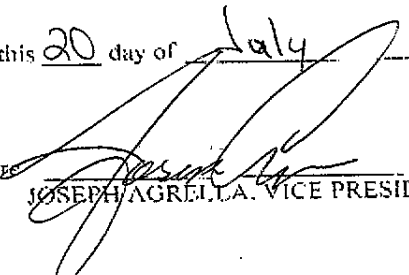
SECOND: There is no exchange, reclassification or cancellation of issued shares.
