ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be:

JOE GREENWELL, COMPETITIVE DIVE BOARD RESURFACING, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 405
Beverly Boulevard, Brandon, Florida, 33511.

ARTICLE III - PURPOSE
