The undersigned, for the purpose of forming a Corporation for Profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation for such corporation:

Article I - Name

The name of the Corporation is ASAB, INC.

Article II - Effective Date

The effective date of the Corporation shall be January 2, 1996.

Article III - Principal Office

The principal place of business and mailing address of the Corporation is 1500 N.W. 49th Street, Suite 609, Fort Lauderdale, Florida 33309. The Board of Directors of the Corporation may from time to time move its principal office in the State of Florida to any other place in this State.

Article IV - Duration

The Corporation shall have perpetual existence unless dissolved pursuant to law.

Article VII - Initial Registered Agent and Address

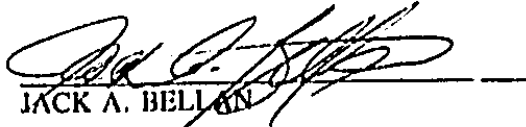
