ARTICLES OF INCORPORATION
OF
BRADLEY + ASSOCIATES, ARCHITECTS, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is BRADLEY + ASSOCIATES, ARCHITECTS, INC.

ARTICLE II

The period of the corporation is perpetual and the fiscal year of the corporation shall be the calendar year. These articles shall be effective immediately upon signing.

ARTICLE III

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and the State of Florida.

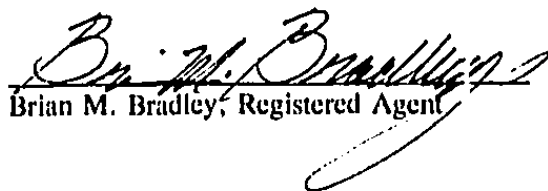
