The undersigned for the purpose of forming a corporation under the Florida
General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is PARTHENON BAKERY & PASTRY SHOP, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To carry on business as bakers and manufacturers of and dealers in bread, flour, biscuits, pastries, cakes, pies and farinaceous compounds and materials of every description.
- 2. To construct, acquire, hire, hold, work, let and sell mills, factories, bakehouses, shops, buildings, machinery and appliances suitable for such baking, manufacturing and dealing.

The aggregate number of shares which the corporation is authorized to

issue is ONE THOUSAND. Such shares shall be of a single class and shall have a par value of One (\$1.00) Dollar.
