The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is Car Stop Corporation.

**ARTICLE II**

**MAILING ADDRESS**

The mailing address of the corporation is One Financial Plaza, Suite 1700, Fort Lauderdale, Florida 33394.

**ARTICLE III**

**CAPITAL STOCK**

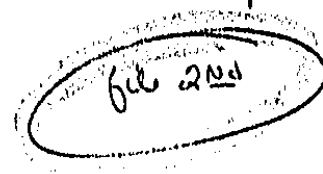

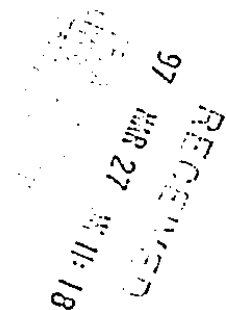
