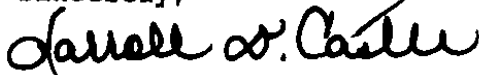

ARTICLE I - NAME:

The name of this corporation is COMMERCIAL CAPITAL CORPORATION Of North Florida, (hereinafter referred to as the ("Corporation")).

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing January 3, 1996, which is the date of subscription and acknowledgement of these Articles of Incorporation.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of transacting any and all lawful business not inconsistent with the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

The Corporation is authorized to issue 10,000 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS:

Every shareholder, upon the sale for cash of any new stock of the Corporation of the same kind, class, or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL PRINCIPAL OFFICE, REGISTERED OFFICE AND AGENT:

The street address of the initial principal office of the Corporation is c/o Harroll D. Castle, 155 Crystal Beach Drive, Post Office Drawer 5649, Destin, Florida 32540, and the mailing address is the same as above. The street address of the initial registered office of the Corporation is the same as above, and the initial registered agent of the Corporation at that same address is Harroll D. Castle.

ARTICLE VII - INITIAL BOARD OF DIRECTORS:

The Corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the By-Laws but shall never be less than one (1). The name and address of the initial director of the Corporation is Harroll D. Castle, 155 Crystal Beach Drive, Post Office Drawer 5649, Destin, Florida 32540.

ARTICLE VIII - INCORPORATOR:

The name and address of the person signing these articles are as follows: Harroll D. Castle, same as above.

ARTICLE IX - BY-LAWS:

The power to adopt, alter, amend, or repeal by By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE X - SECTION 1242-44 STOCK:

It is the intent of this charter that the Director(s) may sell the capital stock of the Corporation in accordance with the conditions of Sections 1242-1244, inclusive, of the Internal Revenue Code of 1986, as amended.
