The Corporation is authorized to issue 1,000,000 shares of Common Stock having a par value of \$.01 per share.

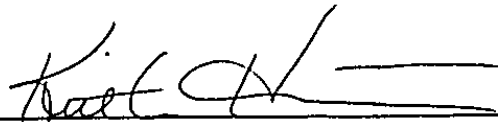
