ARTICLE I - NAME

The name of the corporation is X-RAY PROFESSIONAL SERVICES IMAGING & DIAGNOSTICS, INC., located at 2742 S.W. 8th Street, #24, Miami, Florida 33135.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK
